6 such designation shall hereby be accomplished.


7 On proof provided to and satisfactory to the Court that the designation of the District to

15 commencing upon the date of appointment to the Steering Committee appointed pursuant to
16 "Order for the Appointment of a Watermaster; Powers and Duties" (Civ. No. 1247-SD-T) granted
17 on March 13, 1989, by the Honorable Gordon Thompson, Jr., United States District Judge.


1 IT IS HEREBY STIPULATED AND AGREED by and between the parties hereto, by
 2 their respective counsels or authorized representatives, that Western Municipal Water District
 3 (the "District") is a substantial water user within the Santa Margarita Watershed, eligible to
 4 become a member of the Steering Committee formed pursuant to "Order for the Appointment of a
 5 Steering Committee" (Civ. No. 1247-SD-T) granted on March 13, 1989 by the Honorable Gordon
 6 Thompson, Jr., United States District Judge (the "Steering Committee") and the District is thereby
 7 permitted to appoint a representative to the Steering Committee. The District shall thereafter, as a
 8 member of the Steering Committee, have all the rights and privileges of all other members of the
 9 Steering Committee and shall have an obligation and duty along with all other members of the
 10 Steering Committee, to share in paying all costs, fees and expenditures of the Watermaster




